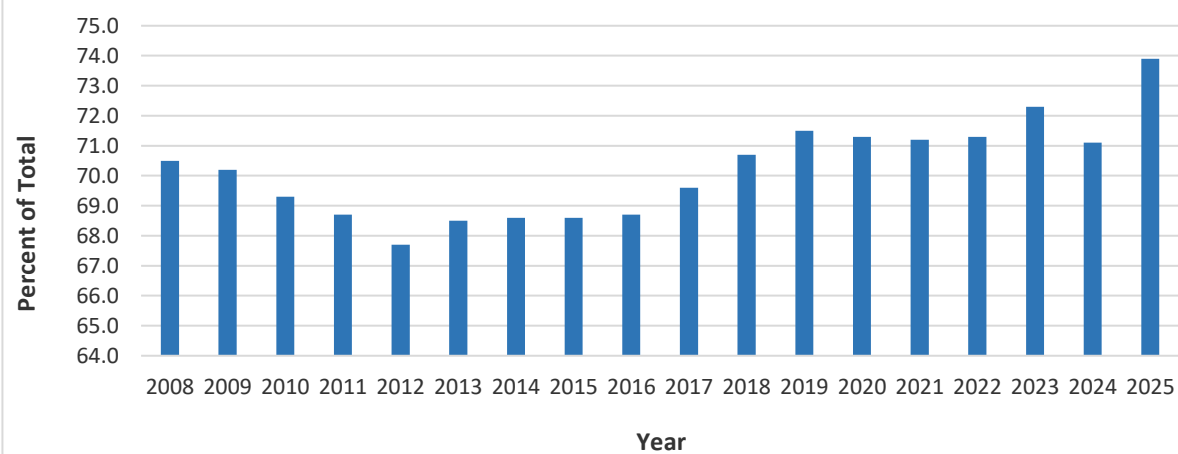

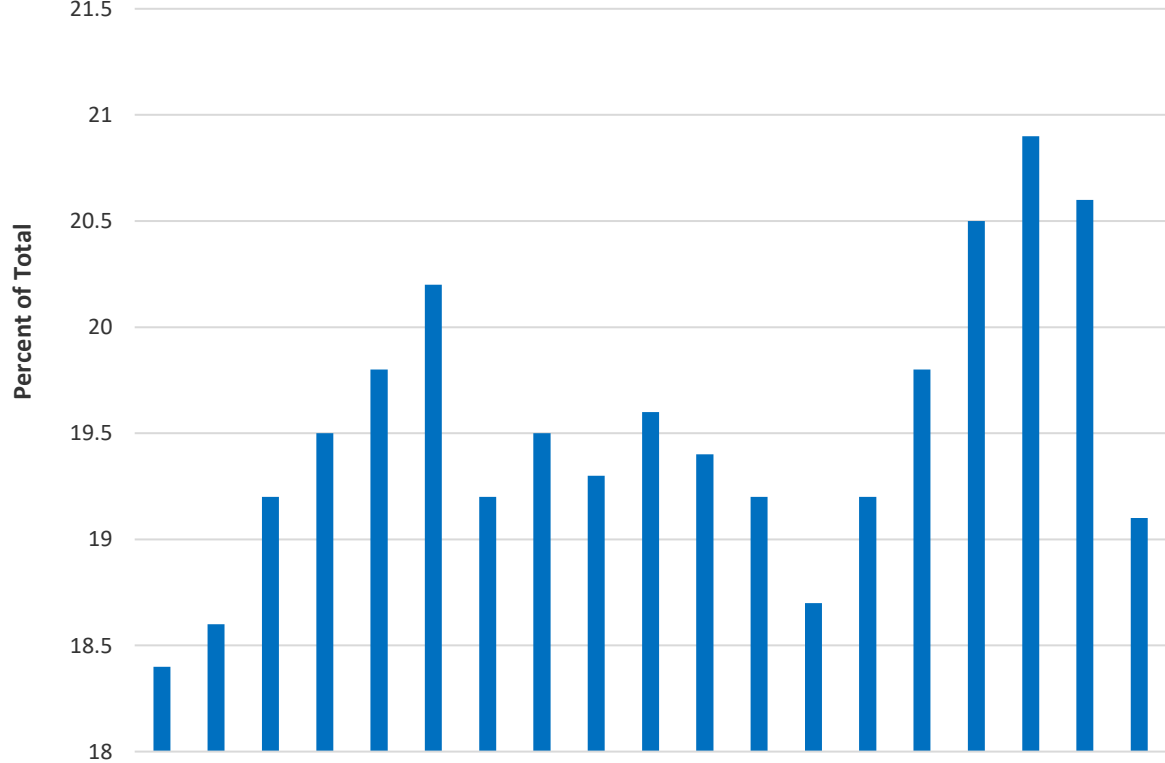

Rock County Equalized Property Values: Residential Segment



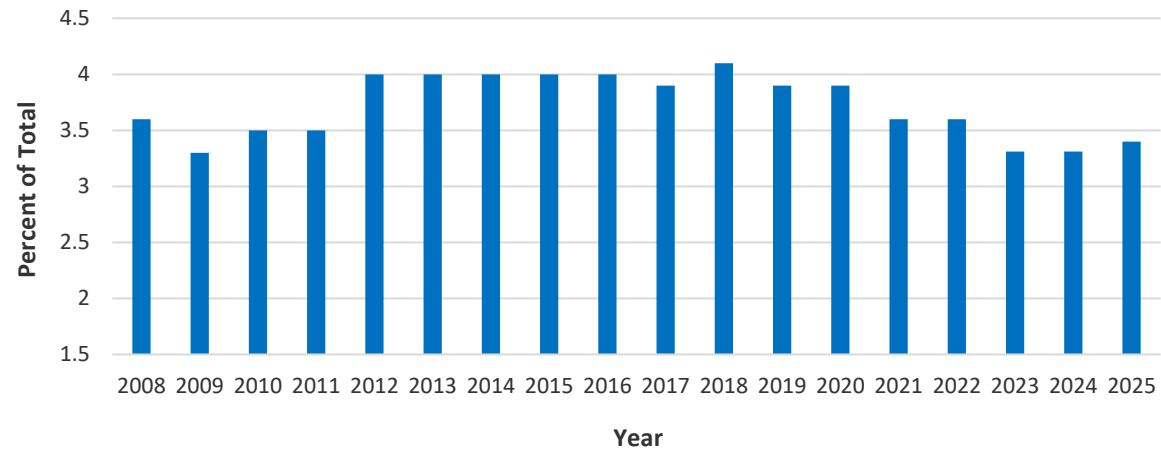
Rock County Equalized Property Values: Commercial Segment
